**Executive Director**  
**Overseas Security Advisory Council**

Scott Campbell is currently the Acting Executive Director of the U.S. Department of State's Overseas Security Advisory Council (OSAC). Mr. Campbell has almost 23 years of government service and spent the last 11 years as a Special Agent with the Bureau of Diplomatic Security.

Prior to OSAC, Mr. Campbell was the Deputy Branch Chief of the Visa Fraud Branch, Criminal Investigations Division. Mr. Campbell also served as the first RSO in Benin, West Africa, the Assistant RSO in Rabat, Morocco, the Special Operations Coordinator for the Diplomatic Security Office of International Programs, and at the Washington Field Office. Mr. Campbell began his law enforcement career working for what is now the Department of Homeland Security. He also served in various assignments as an officer in the US Army's Special Forces.

Mr. Campbell graduated from James Madison University, Virginia in 1982 with a Bachelor of Science degree in Political Science and minors in criminal justice and business administration.

**ROBERT D. BARTON**  
**Regional Security Officer**  
**U.S. Embassy Moscow**

Robert Barton is currently the Regional Security Officer at the U.S. Embassy in Moscow, Russia. Mr. Barton has served the U.S. Government for 21 years, the last 19 years of which have been as a Special Agent with the Bureau of Diplomatic Security.

Prior to arriving in Moscow, Mr. Barton served as a Career Development Officer in the Human Resources Bureau, handling DS' mid-level agents. From 1998-2001, Mr. Barton opened the first RSO office in Ciudad Juarez, Mexico, one of the busiest consulates in the U.S. Foreign Service. He has also served overseas as RSO Buenos Aires ('95-'98) and ARSO La Paz ('88-'90). Mr. Barton's domestic assignments with DS have included the Mobile Security Division ('90-'92), the Physical Security Division ('93-'95), and separate tours in the San Juan (PR) ('92-'93) and Houston (TX) ('87-'88) Resident Offices. Mr. Barton began his law enforcement career working with the U.S. Capitol Police in Washington D.C.

Mr. Barton graduated from Lafayette College (PA) in 1983 with a Bachelor of Arts degree in Business and Economics.

**LEIGH-ANN KENNEDY**  
**Eastern European Regional Coordinator**  
**Overseas Security Advisory Council**

Leigh-Ann Kennedy is the Eastern European Regional Coordinator for the US Department of State's Overseas Security Advisory Council. Ms Kennedy has traveled extensively throughout the region and recent trips include Azerbaijan, Georgia, Turkey, and Poland. She is completing the final stages of a two-week regional assistance visit and comes to us via the Balkans where she inaugurated the first OSAC Country Council in Belgrade. Ms Kennedy also supported OSAC activities during the 2004 Summer Olympics in Athens providing critical updates and analysis to nearly 150 U.S. companies.

Ms. Kennedy graduated from Lynchburg College cum laude in 2002 with a BA in International Relations and minors in Political Science and French.
